**PARTICIPATION RULES**

**EVENT MODIFICATIONS/POSTPONEMENT**

The event programme may be modified and/or postponed to another date for reasons beyond the control of the organization.

Team 69F, at its sole discretion, may stop or suspend the event at any time.

#### CANCELLATIONS

Cancellations must be received at least one week before the date of the event.

#### EQUIPMENT

Team 69F may provide participants with:

- Helmet
- Buoyancy aid

To participate in the event it is necessary to have clothing suitable for sailing activities (in particular wetsuit, sneakers or neoprene boots).

#### BEHAVIOUR DURING THE EVENT

Anyone who in any way puts their own safety and that of others in danger by risky behaviour and/or does not comply with the instructions of Team 69F, may be removed from the event at the sole discretion of the organization.

#### RESPECT FOR RULES

If Team 69F verifies non-compliance with the rules issued, at its sole discretion it may stop the offender and remove them, without reimbursing the event.

#### RESPONSIBILITIES

Team 69F is not responsible for theft and/or wilful or negligent acts against materials or vehicles left in storage at car parks adjacent to the event areas.

#### DISCLAIMER

The participant confirms:

- that they are able to swim independently, to be physically healthy, to be in good health and to be free from diseases that may affect participation in the event;
- that they have not drunk alcohol or eaten food that could harm their health as it is an event that takes place in contact with water, and that they have not taken narcotic substances;
- that they are fully aware of and scrupulously comply with the instructions indicated by Team 69F;
